A Word from our Fire Service Partners

From the Editor: The following column is intended to provide our readers an update on fire service activities from around the state.

Office of the Illinois State Fire Marshal

The Office of the Illinois
State Fire Marshal (OSFM)

has announced the recipients of the 2024 Small Equipment Grant Program. A total of \$4 million was awarded to 165 fire departments/districts and EMS providers across the state. The program was established to provide grants of up to \$26,000 each for the purchase of small firefighting and ambulance equipment.

This program is an innovative approach to a problem that has long caused difficulties for fire departments and not-for profit ambulance services in Illinois, particularly those that have hardships in generating the necessary revenue for small equipment. The purpose is to allow eligible applicants the opportunity to purchase small equipment that they may otherwise not be able to purchase. The OSFM received 417 applications, requesting around \$9.5 million in funding for this grant period.

Most Illinois fire departments, fire protections districts, township fire departments, and stand-alone, nonprofit ambulance service providers were eligible to apply. All fire departments, fire protections districts and township fire department applicants were required to have participated in the National Fire Incident Reporting System (NFIRS) for a minimum of two years prior to applying.

The Be Alarmed! Smoke Alarm Installation program is a fire safety and smoke alarm installation program administered cooperatively between Camp I Am Me and the Office of the Illinois State Fire Marshal. The program distributes fire safety education materials and 10year sealed battery smoke alarms to fire departments in Illinois - all at no-cost. There are now more than 280 departments across that state that participate in the program, which has resulted in the distribution of more than 32,000 smoke alarms since 2018. Happy Spring! At our January 2024 meeting, the IFSAP Executive Board took an extensive look at what IFSAP was in the past, and how it will continue to evolve & grow within the fire service. We look forward to continue offering amazing educational opportunities, continuing to expand our membership throughout Illinois and reviewing the regions that IFCA utilizes, we are also reaching out to all departments and districts down state to help create regional representation.

We are proud to announce that IFSAP has partnered with the Illinois Fire Fighters Peer Support organization, and they are now offering a 1-day program specifically designed for the Administrative Professional in the Fire Service. Our first 2 classes were full, and we currently have a waitlist for the next class and plan to schedule this for summer 2024.

The responsibilities of administrative professionals in the fire service can be stressful and demanding. They may

encounter challenges such as managing critical information, interacting with personnel in distress, handling logistics for emergency responses, and supporting firefighters dealing with unimaginable scenarios on calls. The pressure to perform efficiently in a fast-paced environment while dealing with the emotional toll of the job can lead to increased stress, anxiety, and burnout among administrative staff.

Many admins understand that we are a trusted person within our organizations, and there is a comfort level that many have with the front-line workers. Recognizing changes in physical and verbal cues is one part, understanding the appropriate actions and resources to help them and potentially save their lives is another. Mental health awareness among administrative professionals in the fire service is crucial, despite their roles not directly involving firefighting. Admins play a pivotal role in supporting the operational aspects of the department, and their well-being is essential for maintaining the overall functioning of the organization.

Ultimately, prioritizing the mental wellness of ALL staff, including administrative professionals, contributes to a more resilient and cohesive fire service community. We want to thank the Illinois Fire Fighters Peer Support for designing this program for us.

While we are always looking to expand our membership, we also need to expand our inclusivity to those departments outside of the Chicagoland area. This means reaching out to the farthest parts of our great state of Illinois and ensuring that we address the concerns of those departments and districts. A new committee has been formed within IFSAP to further expand on the use of long-distance communication and collaborations. If you're a district or department down state and your admin is interested in being a regional rep for your area please reach out to us.
