### About the Cover:

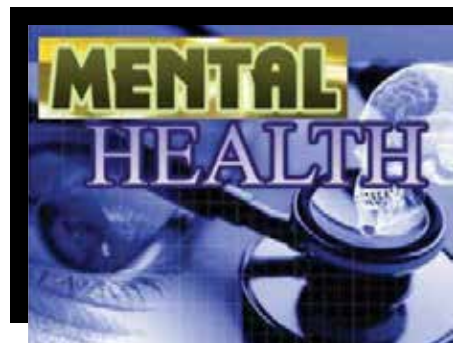
